How many offshore rigs will GlobalSantaFe operate?

The merged \$6 billion company, GlobalSantaFe Corp., will operate 59 offshore rigs. HOUSTON, Sept. 4 -- Global Marine Inc., Houston, and Santa Fe International Corp., Dallas, said Monday they plan to merge in a stock-for-stock transaction that will create the world's second largest offshore drilling contractor.

Who owns Santa Fe drilling rigs?

GlobalSantaFe Corporation was an offshore drilling contractor headquartered in Houston, Texas. It owned 59 marine drilling rigs. In November 2007, the company was acquired by Transocean. The company was formed in 2001 by the merger of Global Marine and Santa Fe International Corporation.

Will Global Marine & Santa Fe merge?

Global Marine Inc., Houston, and Santa Fe International Corp., Dallas, said Monday they plan to merge in a stock-for-stock transaction that will create the world's second largest offshore drilling contractor. The merged \$6 billion company, GlobalSantaFe Corp., will operate 59 offshore rigs.

How will Global Marine & GlobalSantaFe combine?

The combined company's operations will be 25% Gulf of Mexico and 75% international, "which is an extremely good balance," said Garber. Under the deal, Global Marine stockholders will receive 0.665 shares of newly issued GlobalSantaFe stock for each share of Global Marine and will own 50.6% of the combined company.

What happens if global marine buys GlobalSantaFe?

Under the deal, Global Marine stockholders will receive 0.665 shares of newly issued GlobalSantaFe stock for each share of Global Marine and will own 50.6% of the combined company. Gains on the transaction will be taxable to Global Marine shareholders.

How many drilling rigs does Global Marine have?

Global Marine operates 33 jackups, semisubmersibles, and dynamically positioned ultra-deepwater drillships. Santa Fe has 26 marine drilling rigs, including semisubmersibles and premium and heavy duty harsh environment jackups, and 31 land drilling rigs. It also operates 13 rigs for others.
