



## Caodc drilling rig wages 2017

What is the drilling and service rig industry in Canada?

The drilling and service rig industry in Canada is very unique in that the equipment, vehicles, and processes are very specialized. As operations extend across Canada, they tend to fall under various regulations and legislation that was never intended for this industry.

What is a drilling and service rig Association?

The Association works on behalf of its membership in government and public areas and is responsible for developing standard procedures for member companies. The drilling and service rig industry in Canada is very unique in that the equipment, vehicles, and processes are very specialized.

Are drilling and well servicing rigs a commercial hauler?

However, in Canada, drilling and well servicing units fall under TDG regulations which treat all drilling and well servicing rigs as if they were commercial haulers, transporting dangerous goods across the country.

Do Canada's drilling and service rigs need a Pels permit?

To comply with these regulations, Canada's drilling and service rig fleet must operate with Permits of Equivalent Levels of Safety (PELS) or shut down operations -- as purpose built units simply cannot be engineered and constructed to the specifications required of highway transportation vehicles.

How will the CAODC move forward?

In order to move forward, the CAODC is beginning to search for alternatives to present to Transport Canada that would demonstrate an equivalency to current legislative requirements. Over the coming months, the CAODC will conduct a complete analysis of member companies operations through an intensive hazard assessment.
