Did a man die from an oil rig explosion & fire?

November 14, 2017 - A man was seriously hurt in an oil rig explosion & fire in White County, and later died from his injuries. In September, 1941, a nine-hour conflagration at the Whiting Standard of Indiana refinery killed one man and injured 20 others.

Where were offshore drilling rigs made, primarily?

Until the early 1970s, most offshore drilling rigs were built in U.S. yards (31 of the 327 rigs listed here were built in a year beginning with a 2). The offshore drilling rig was invented in Texas.

What happened to the Mid-Valley crude oil pipeline?

December 25 - A Mid-Valley crude oil pipeline exploded and burned, at a pipeline terminal, in Lima, Ohio. The fire spread to a holding tank, forcing nearby residents to evacuate. January 15 - A leak was discovered in an 8-inch pipeline belonging to Plantation Pipeline in Floyd County, Georgia.
