What should a drilling contract include?

A drilling contract should address the standard of performance expected of the drilling contractor. The API drilling contract form requires the contractor perform "with due diligence and care, in a good workmanlike manner, and in accordance with good drilling practices."

What are drilling contracts & agreements?

Drilling contracts or agreements are a must to define the work scope, obligations & prices between the oil companies and their contractors.

How do drilling contracts work?

This information is generally provided through the Regional Geotechnical Section. However, there are occasions when additional assistance is necessary. At those times, drilling contracts are let to procure the services of companies experienced in obtaining subsurface information, soil and rock samples, for geotechnical engineering purposes.

What is an API drilling contract?

The API drilling contract form requires the contractor perform "with due diligence and care, in a good workmanlike manner, and in accordance with good drilling practices." The drilling contractor represents that it "is engaged in the business of drilling and completing ... wells ...."

Can a drilling contractor disclose drilling information to third parties?

Most drilling contracts contain a provision that upon the written request of the operator, the drilling contractor may not divulge drilling information to third parties. The contractor also promises that its employees will not divulge any drilling information to third parties.

What is a well drilling agreement?

In this agreement, the oilfield company needs to provide the action plan and objectives of well drilling, the well location, essential data, and target depth to the drilling contractors. After getting the instructions, the drilling engineers design the well and execute all the drilling activities.
