Where can I find the logical oil and gas industry standard contracts?

The oil and gas industry standard contracts developed under the CRINE initiative and now administered by LOGIC are now available on-line through the LOGIC website (). Until now, the contracts have only been available in hard copy.

How many standard contracts does logic support?

LOGIC currently supports a suite of 11 Standard Contracts that are available for use throughout the oil and gas industry and these are currently being reviewed and updated. They cover a broad range of operations in the UKCS and are widely used across the contracting community.
