Who are the largest offshore drilling rig contractors?

The accompanying table lists the ten largest offshore drilling rig contractors in terms of managed fleet size, meaning the figures include rigs that are managed on behalf of other owners. China's state-run China Oilfield Services Limited, or COSL, continues to hold onto the top spot on the list with 58 rigs under its management.

What is an offshore rig company?

An offshore rig company, also known as an offshore drilling business, is a specialized business that provides offshore oil and gas production services. These companies operate, manage, and maintain offshore drilling rigs, platforms, and associated equipment in oceans or seas.

Why are offshore rig firms important?

Offshore rig firms play an essential role in the oil and gas sector because they facilitate the exploitation of hydrocarbon reserves beneath the seabed. They provide various services, such as well drilling, installation, maintenance of production platforms, exploration activities, and logistical support.

Who manages the rigs?

Energy Drilling manages the tender-assist rigs, while the others manage the drillships and semisubs. As of the end of 2021, the ten largest offshore rig contractors managed 44% of the global rig fleet of 723 jackups, semisubs, and drillships. This includes units under construction but not yet delivered.

How many offshore drilling rigs are there in 2021?

The global supply of offshore drilling rigs continued to shrink last year, even as demand picked up across multiple regions. At the end of 2021, the total supply of drillships, semisubs, and jackups was 723. By the end of 2022, the total had fallen to 709.

How did the rig owner's contract drilling services revenue perform in 2024?

The rig owner's contract drilling services revenue for the third quarter of 2024 totaled \$764 million compared to \$661 million in the second quarter of 2024, with the sequential increase driven primarily by an approximate four weeks of contribution from the legacy Diamond fleet.
