Does Patterson-UTI have a high-spec drilling rig?

Patterson-UTI operates a high-spec drilling rig, specifically the Apex PK model. Patterson-UTI Energy, Inc. (NASDAQ: PTEN) is a drilling specialist in the United States that revealed Tuesday it will add 16 super-spec rigs to its 150-rig domestic fleet.

Is Patterson-UTI a good oil rig company?

Patterson-UTI, an oilfield services company based in Houston, TX, was founded in 1978. It is a good company suited for being part of a bigger well service rig business or as a specialized independent firm. The company came into its current form following a merger between Patterson Energy, Inc. and UTI Energy Corporation.

After the acquisition of Pioneer, Patterson-UTI will possess 166 super-spec rigs in the United States with nearly 50 % being outfitted with alternative power sources to minimize emissions.

Patterson-UTI's CEO, Andy Hendricks, announced, "As a leading provider of contract drilling services in the United States, we are proud to announce this transaction." The company will benefit from Pioneer's high-quality fleet of 17 drilling rigs in the country, 16 of which are super-spec.

Did Patterson-UTI drill a new well?
