Who owns Penrod drilling Corp?

DALLAS -- Energy Service Company Inc. and the investment firm of R.D. Smith and Co. Inc. said Friday they closed the purchase of the remaining 31.3 percent of senior debt and equity securities of Penrod Drilling Corp. Penrod, one of the largest offshore drilling companies, had been owned by the trusts of the Hunt brothers of Dallas.

Who owns the Penrod 61 rig?

The Penrod 61 was a Marathon LeTourneau Jack-Up Rig owned by Penrod Drilling Co. and leased by Chevron USA that was working in the Gulf of Mexico in October of 1985. Before Hurricane Juan slammed into the Rig, the bottom of the rig's hull stood 50 feet above sea level of the Gulf of Mexico.

How many rigs does Penrod have?

Eventually, the Penrod rig fleet was expected to consist of 18 to 20 offshore rigs, eight to 10 land rigs, and two supply vessels, the companies said. It said the offshore rig fleet represented one of the newer fleets in the industry with an average rig age of about 10 years.

Who owns Penrod 73 & 78 rigs?

Energy Service Co. Inc. (EnSCO), Houston, and R.D. Smith & Co. Inc., New York, have agreed to sell two more Penrod Drilling Corp. semisubmersible rigs. Penrod 73 and 78 are to be sold for \$90 million to AS HAV, an affiliate of Helmer Staubo & Co., Oslo.
