



## Water drill rig licence

How do I get a well driller license?

Submit a completed Well Driller and or Pump Installer License Application (PDF) with the non-refundable fee listed below: A driller or installer license is valid for a period of two years from the date of issue.

Do I need a license to drill a water well in Wisconsin?

In Wisconsin, a license or registration is required to engage in the business of pump installing, water well drilling and heat exchange drilling. Licensing authority is established under s. 280.15, Wis. Stats. [exit DNR]. Licensing laws are promulgated through ch. NR 146, Wis. Adm. Code [exit DNR].

How do I get a water well drilling license in Texas?

Important: For water well drilling vehicles and equipment, you must provide proof of a current license from the Texas Department of Licensing and Regulation (TDLR) to obtain a Machinery license plate. Completed applications may be submitted in person or by mail to any TxDMV RSC.

Do I need a license to drill a well in Texas?

A license is required to drill a water-related well in Texas and to install a pump for a water-related well. TDLR regulates private water well drilling and pump installation. A license is required to drill a water-related well or install a pump for a water-related well in Texas.

Do you need a license to install a water well?

Ch. NR 146 Wis. Adm. Code [exit DNR] requires pump installers, and drillers to pass an exam before obtaining a license to engage in the business of water well drilling, heat exchange drilling or pump installing. The license exam evaluates an individual's knowledge of current regulations and industry practices.

How do I become a rig operator in Wisconsin?

Register: A rig operator must register and work under the supervision of a Wisconsin licensed heat exchange driller before drilling experience accrues and is applicable towards NR 146.04 (9) (a) [exit DNR] experience requirements. See the rig operator registrations tab for information on how to apply. Submit license application form 3300-300 [PDF].

The annual fee for a water well drilling/pump installer license is one hundred dollars (\$100) for a calendar year; whether it is for one or both endorsements. Please make your check or money ...
